Treasurer's Report: Dave Larsen

- August numbers are not complete, but coming in pretty close to what projections state.
- End of the year projections look like we are spending \$10,000 more than expected and receiving \$10,000 less than expected.
- Pledged amount is about 5% below expected. We are not getting a lot of new pledges.
- Dave L. suggested the ERC (Employee Retention Credit- approx. \$15,000) be transferred to the operating reserve account.

Mission/Vision Task Force Update: Dave Chura

- Mission/Vision Task Force Timeline
- Dave reviewed the process that organized MVTF Recommendations into green, yellow, and red.
- The purpose of the VC Fall Forums is to present information regarding how the Vision Council has categorized the recommendations.
 - o Remind people how we got here
 - Show how the VC "bucketed" the recommendations
 - Listen and clarify when needed
 - Use this as an additional way to gather information
 - It would be helpful if someone from the VC led other than Dave C. and Sara H.
 (who were both on the MVTF). It is a priority for VC members to attend forums.
- The color coding of recommendation would then essentially be the "blueprint" for the HR
 Committee and Resource Development Committee to move forward in partnership with
 the staff in creating a budget, etc.
- The goal is to have one Sunday 11:00 and one Wednesday evening forum.
